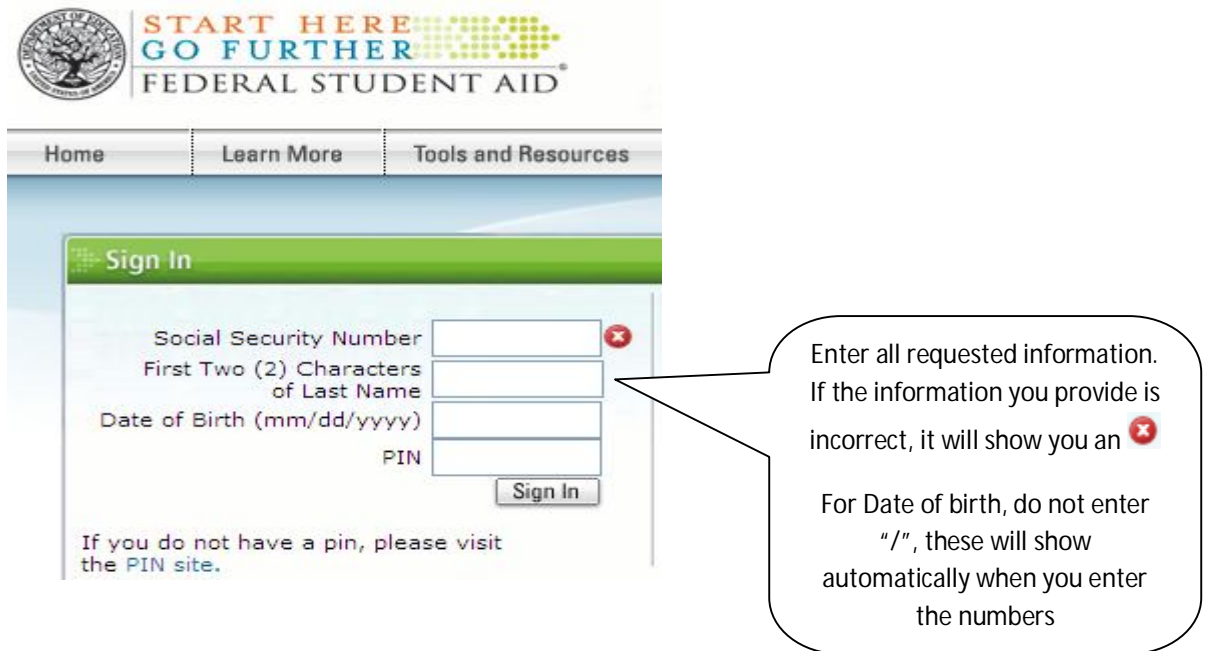


Completing the Entrance Counseling (EC) with Direct Loans

1. In order to complete the EC, go to <https://studentloans.gov/myDirectLoan/index.action> . You will be required to login to complete your EC, please make sure you have with you:
 - a. Your Social Security#
 - b. Your Date of Birth
 - c. Your PIN



2. After you click on "Sign In", the next page will show where to enter your information.



3. Once you have logged in, it will ask you to confirm your information on the right and on the left it will provide you options to complete the EC, please click on "Complete Entrance Counseling"
