

**UMA CAREER CONNECTER GIVEAWAY
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

THE UMA CAREER CONNECTOR GIVEAWAY (REFERRED HEREIN AS THE “GIVEAWAY”) BEGINS AT 12:00 A.M. EASTERN TIME (“ET”) ON JUNE 1, 2019 AND ENDS AT 12:00 P.M. ET ON JUNE 1, 2020 (THE “GIVEAWAY ENTRY PERIOD”).

ELIGIBILITY: Giveaway is open to legal residents of the fifty (50) United States, and the District of Columbia age 18 or older who are graduates of UMA. This Giveaway is being hosted by UMA Education, Inc. d/b/a Ultimate Medical Academy (the “Sponsor”). Giveaway is governed by U.S. law. Giveaway is subject to all applicable federal, state and local laws and regulations.

HOW TO ENTER:

Graduates who submit qualified job referrals through the online form located at <https://www.ultimatemedical.edu/career-connector/> (“Entrants”) may be eligible to receive a Giveaway prize. Qualified job referrals are those verified as new positions that match UMA’s program criteria. Job referrals must be related to positions within the allied health field, with job education requirements that are encompassed by UMA’s program offerings and do not exceed an associate degree. Examples of qualified job referrals can be found on the website linked above under “Job Title Examples.” Entrants whose qualified job referrals result in a job placement are eligible to receive additional prizes. Job placements are defined as employment for more than three continuous business weeks and is verified by UMA via the employer and/or graduate. All entries become the property of Sponsor and will not be acknowledged or returned. Entrants may submit more than one referral, however duplicate referrals for the same position will not be counted.

PRIZE DETAILS & APPROXIMATE RETAIL VALUE (“ARV”): Values for individual prizes can be found as Appendix 1. Prizes are based on tiers. Entrants with 1 UMA-approved qualified referral may receive the “Referrer” prize. Entrants with 2-5 UMA-approved qualified referrals may receive the “Ultimate Referrer” prize. Entrants with 6+ UMA-approved qualified referrals may receive the “Platinum Referrer” prize. Entrants with 1-3 job placements may receive the “Career Connector” prize. Entrants with 4-6 job placements may receive the “Ultimate Career Connector” prize. Entrants with 7+ job placements may receive the “Platinum Career Connector” prize. No manufacturer of the given prizes is a participant in or sponsor of this promotion. Prize will be awarded as is. Prize components, including color and/or any specifications associated with the prize are at the sole discretion of the Sponsor. Prize value is determined by manufacturer's suggested retail price or by what the items are currently known to be selling for at the time these Official Rules were published and is subject to change. SELECTION OF WINNERS: All Giveaway prizes are given at the discretion of UMA. A representative of UMA will review the job referrals and note which ones are qualified based on the criteria above. Entrants with UMA-approved job referrals may be selected to receive a prize. If a potential prize winner does not wish to accept the prize, or if an entrant is otherwise found to be ineligible, or if the selected winner cannot accept or receive the prize for any reason, the potential prize winner will forfeit the prize and at Sponsor’s sole discretion, an alternate winner maybe selected.

If a potential winner is considered a minor in his/her state of primary residence, a parent or legal guardian will be required to receive the prize on the winner's behalf. The Sponsor reserves the right to modify the notification procedures in connection with the selection of an alternate winner, if any.
